Detailed Report of the Programme:

The Chief guest commenced the workshop by defining the term 'Money Laundering' and enumerated the need for an act globally. He examined the measures taken by G-7 summit to combat money laundering through establishment of the Financial action task force, its membership, objectives and role at the global level. The speaker initially gave an overview of the standards established globally and later spoke about the Parliamentary history of law in India and how it evolved into the passing of 'Prevention of Money Laundering Act' 2002, its preamble and administration. He threw light upon the details of stages in money laundering cycle and the multiple agencies involved in the investigation and prosecution of money laundering offences.

He shared few live examples of money laundering and the route adopted to avoid its detection. He said, Enforcement Directorate is the investigating and prosecuting agency for offences committed under PMLA. Finally, he narrated a few fake transactions which are suspicious in nature and elaborated how the proceeds of the crimes are legitimised to obscure the money trail.

Outcomes of the Event/ Programme:

The students questioned the speaker about the quantum of money deposited deemed to be money laundering, suspicious transaction and the regulated entities which are bound to trace and report such offences. The students evinced keen interest on the live instances of money laundering quoted by the chief guest in the session. It also guided the interested candidates to look out for employment opportunities in Enforcement Directorate by appearing for UPSC examination.
