Whereas "PARTY OF THE FIRST PART" is in the field of MEDIA and has vast Practical Experience for the past 33 YEARS

Whereas "PARTY OF THE SECOND PART" is an Educational Institution, a Trust in the name of DWARAKA DAS GOVERDHAN DOSS VAISHNAV COLLEGE, offering additional courses along with their regular courses by awarding SAMAS-D.G.VAISHNAV DIPLOMA IN ONSITE MEDIA PRACTICAL TRAINING COURSE(OMPT)

Whereas "PARTY OF THE SECOND PART" had approached "PARTY OF THE FIRST PART" to conduct a 'ONSITE MEDIA PRACTICAL TRAINING' (OMPT) at its college irrespective of any particular Department or Division and "PARTY OF THE FIRST PART" has agreed to the same through THIS MEMORANDUM OF UNDERSTANDING from JULY 2019 of the Academic Year 2019-20 till the end of the Academic Year 2021-22 for 3 YEARS. This MOU will be after 3 Years based on the Understanding between the Party of the First Part and the Party of the Second Part before the end of the Academic Year 2021-22 to pursue OMPT & Other Certificate and Diploma Courses in the college premises.

HENCE THIS MEMORANDUM OF UNDERSTANDING WITNESSETH THE FOLLOWING:-

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSETH

That in consideration of the mutual covenants herein before recited the parties hereto agree as follows:

1. The Diploma course to be offered by "PARTY OF THE FIRST PART" will be known as ONSITE MEDIA PRACTICAL TRAINING"(OMPT) and the duration of the course shall be for a period of THREE YEARS
2. The first batch of the Course shall commence from JULY 2019. The fee for the diploma course per student shall be Rs.15,000/- (Rupees Fifteen Thousand only) and Rs.750/- per student for the Certificate from the Ministry of Human Resource Development (HRD) to the students for their employability. Hence the Total Fee will be Rs.15750/- (Rupees Fifteen Thousand Seven Hundred and Fifty only)
3. The entire 3Years fee shall be paid in advance by "PARTY OF THE SECOND PART" to "PARTY OF THE FIRST PART" through RTGS/NEFT to the "PARTY OF THE FIRST PART" for which the Current Account Number would be provided to "PARTY OF THE SECOND PART" in due course. This fee structure may be revised after 3 years at the time of renewal of this MOU in the Academic Year 2021-22. Study materials & Assignments details will be imparting by SAMAS through Online Access to the students after the induction & Fee transfer to the "PARTY OF THE FIRST PART" by the "PARTY OF THE SECOND PART" for the Onsite Courses

4. No interference will be entertained by the "PARTY OF THE SECOND PART" in the design of the syllabus and Online Access of the "PARTY OF THE FIRST PART". This shall be the exclusive property of the "PARTY OF THE FIRST PART" and no person or persons connected to the Party of the Second Part or Institution has the right to copy the same in any manner. The Examinations will be conducted by the "PARTY OF THE FIRST PART" unlike the other University Examinations and it will be in the form of Subject Assignments based on the Attendance of students, to enable the students for their learning without fear in Practical Media Subjects. The Theory and Practical Assignment paper corrections will be made under the New System of "PARTY OF THE FIRST PART" designed for this ONSITE MEDIA PRACTICAL TRAINING"(OMPT). The Final Syllabus Courseware copy pertaining to each Semester will be provided to the PARTY OF THE SECOND PART after signing MOU with the Institution
5. Syllabus for the Onsite Courses will be communicated through online to "PARTY OF THE FIRST PART" to the students directly. The Total Duration of the Hours for OMPT will be in 90 days or Hours of the total 3 YEAR DEGREE COURSE and it is designed 1 Hour or 2 Hours per Session according to the subject(s) in each semester and the total hours will not exceed 30 Hours per semester of the Academic Year for 3 years
6. SAMAS MEDIA ACADEMY has assured and specially provided room for learning OMPT by the students who enrolled in 2017-18, now in III Year students and 2018-19, now in II year students are also be eligible for admission by paying the Full Fee of 15,750/- for OMPT course. The syllabus for the I year will be covered for the II year students(Enrolled in 2018-19) within this academic year along with this year OMPT course. Likewise, the syllabus for I & II year will be covered for the final year students (Enrolled in 2017-18) within 5th semester as a special coaching to encourage the Final year students to get the Diploma Certificate from SAMAS - DG VISHNAV Collaborative Certificate to satisfy them also to get the employability in the Media.

COLLABORATIVE "SAMAS-D.G.VAISHNAV" DIPLOMA IN 'ONSITE MEDIA PRACTICAL TRAINING' OMPT CERTIFICATE will be awarded to all students who will be completing the course, by the "PARTY OF THE SECOND PART" during their Annual Convocation of the Institution every year to encourage them towards positivity in their life.
11. "PARTY OF THE SECOND PART" shall Provide Smart Class rooms with CCTV Surveillance Camera facilities, Provision for Power Point Presentation, Laptop Tables, Loud Speakers & required seating arrangements for the faculty and students as requested by the "PARTY OF THE FIRST PART"
12. "PARTY OF THE SECOND PART" shall Provide Quality Infrastructure such as the rooms for Faculties & Coordinator separately, Ambient Learning Environment as required by "PARTY OF THE FIRST PART" for conducting the Onsite Media Practical Training(OMPT) in a Professional manner in the premises of the "PARTY OF THE SECOND PART"
13. "PARTY OF THE FIRST PART" should allow the Onsite Course students to go out for Practical Media Field works for the assignments on any day to be assigned by "PARTY OF THE FIRST PART" from time to time based on the Curriculum designed by "PARTY OF THE FIRST PART" for Onsite Courses

"PARTY OF THE SECOND PART" shall be Responsible for Fee Collection from Students & Admission Process in a Collaborative Admission form to be issued after the signing of this MOU and shall maintain proper accounts in respect of the fees collected from the students and ensure that it complies with the requirements of all Tax statutes.
15. "PARTY OF THE FIRST PART" should ensure that it brings the best Media Experts from known Industry sources "PARTY OF THE FIRST PART" should ensure Key roles for Academic and uninterrupted classes. 




Whereas both the Institutions (**I C A I** & **D G V C**) have identified the following areas of mutual co-operations:


