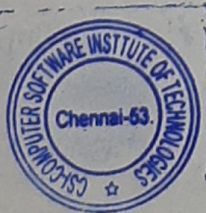

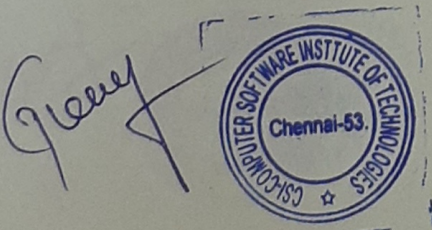



Clause 1 CO-OPERATION

Clause 2 SCOPE OF THE MOU

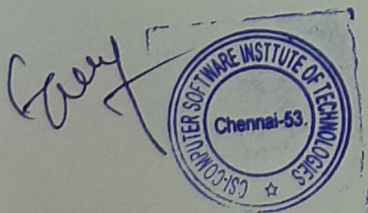
2.1 Both parties believe that close co-operation amongst the two would be a foremost benefit to the student community to augment their skills and knowledge.

3.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to release their obligations.

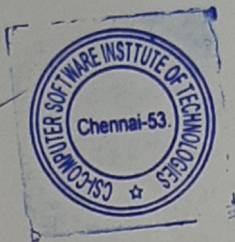
3.3 Any disagreement will be settled in the court only.
