Article 1: Objectives:

Article 2: General Areas of Cooperation:

- b) Exchange of Academic publications, information and research resources
- c) To collaborate for undertaking projects/ activities in tune with the needs.
- d) To conduct orientation programmes for faculty, students and Library staff and to work for the promotion of research and Library services.
- e) To conduct Information Literacy programmes for the students to enhance their knowledge and skills.
- f) To promote the application of Information Technology in Library and Information Services.
- g) To conduct State level, National level and International level conferences, Seminars, workshops, Training programmes, Lectures in the areas of Library and Information Science for the students/Library staff of **Dwaraka Doss Goverdhan Doss Vaishnav College, Chennai** or Library professionals/students in the region/state, scientific publication and research promotion activities and skill development
- h) Provide a common forum/network of Library and Information Science (LIS)

Before taking up these activities, both parties shall discuss the problems involved with mutual satisfaction and enter into specific activity – agreements, based on the forms of implementation mutually agreed upon.

Article 3: Administration:

Both parties agree that, prior to the initiation of a particular exchange and any other activity encompassed by this agreement, all regulations related to the application of particular exchange and collaborative activity shall be settled in detail in writing.

Article 4: Programmes and Financial Commitment

A minimum of 2-4 programmes need to be organised in an academic year such as Conference/Seminar/Workshop/Training Programmes/ Orientation Programmes for students/ Lectures/ Information Literacy Programmes for Students for effective utilization of Library Resources, Cultivation of reading Habit, Skill Development and other related programmes)

Article 5: Effect:

This agreement becomes effective when signed by the representatives of the two parties.

Article 6: Coordinators

The Librarian of DDGDVC will be the coordinator representing the college. The Chairman of the respective **SALIS** chapter will be the coordinator representing the SALIS. The Chairman of the **SALIS** Chennai Chapter and his/her team members will extend professional support for conducting programmes if needed.

Article 7: Duration:

This agreement will be in force for a period of five years and automatically be renewed. However, at any point of time, the Parties to this MoU may terminate the agreement by giving six-months notice in writing of such intent.
