COURSES OFFERED

The course curriculum of B.Com Finance & Taxation is integrated with ACCA, with an exemption of six out of thirteen ACCA papers. Moreover, another three papers are integrated into the syllabus, which are treated as non-exempted papers. ISDC (International Skill Development Corporation), SOE Global who is our official partner for ACCA integration, conduct ACCA classes in the campus exclusively for the three non-exempted subjects.

ELIGIBILITY FOR ADMISSION

Candidates for admission to the B.Com. (Finance & Taxation) programme shall be required to have passed the higher secondary examinations under Commerce stream with commerce and accountancy (Academic or Vocational Stream) conducted by the Government of Tamil Nadu or an examination accepted as equivalent thereof by the Syndicate of the University of Madras
